

This is with reference to your application on the subject cited above. 5. That the school shall comply with Clause 14 of order No.DE/15(56)/ACT/2009778 dated 11.02.2009 in r/o maintenance of DRF. School shall also follow FN-21 "Accounting by Schools" as issued by the Institute of Chartered Accountants of India (ICAI) for proper accounting treatment.
6. That the school shall make payment of salary and other admissible allowances to its teaching/non-teaching staff as per ongoing CPC through bank/RTGS and submit requisite documents within 02 months to the district authority.
7. That the school shall submit the Police Clearance Certificate regarding Police Verification in r/o entire teaching/non-teaching staff within 02 months to the district authority.
8. That the school shall submit the documentary proof regarding maintenance of DRF account in any scheduled bank of India within 02 months to the district authority.
9. That the school shall comply with the order No.F.No.DE.15(305)/PSB/2020/Pt.File-I/5658-5662 dated 21.06.2023 with regard to appointment of Special Educator.
10. That the school shall comply with the order No.DE.15(305)/PSB/2020/Pt.File-I/5641-47 dated 20.06.23 regarding submission of renewed / updated certificates like Fire NOC, Water Test report, School Health Certificate, School Building Certificate/Structural Stability Certificate to the zonal authorities of DoE.


